The Columbia Valley Community Foundation is excited to be celebrating 15 years of supporting our donors in creating long-term legacies in our community. Because of the vision of the Columbia Valley Community Foundation founders and the commitment of long-serving board members, over the past 15 years we have supported over 131 community projects and granted back over \$540,000 to the community.

A heartfelt thank you goes to our donors and fund holders. Your generosity makes possible our daily work of improving the quality of life in our community and we are grateful.

2016 was a busy year for the Columbia Valley Community Foundation. Here are some of the highlights:

We completed our community's first Vital Signs report. The community response was overwhelming; 1067 residents completed the survey. Vital Signs is a "community snapshot"; our goal was to stimulate discussion and action by underscoring our strengths and opportunities in our communities. A summary of the report is located in this annual report. Over time, with completion of subsequent Vital Signs reports our understanding of our community will increase, helping to direct our grantmaking and to connect donors to community needs. We ask that you share the Vital Signs report with members of the community and complete future Vital Signs surveys.

Celebrating 15 Years of Creating Legacies in the Community


Columbia Basin Trust strengthened their partnership with Columbia Basin community foundations though the establishment of a no-fee, flat-rate investment option. The investment is flexible allowing deposits and withdrawals every quarter, if required. The Columbia Valley Community Foundation has taken full advantage of this fund by depositing the majority of our unsecured funds. We also use this investment to deposit donations to the community foundation so that all gifts can immediately start to gain investment income. As well, Columbia Basin Trust believes in further supporting Columbia Basin community foundations and has committed to a 3 year community foundation collaboration project that will include support for additional training and marketing for our board members and staff. We are extremely thankful and truly appreciate the opportunity to work more closely with Columbia Basin Trust and our fellow community foundations in the area.

In anticipation of Canada's 150th, our national organization, Community Foundations of Canada provided a matching grants program for projects celebrating and/or creating legacies for Canada's sesquicentennial. It was a wonderful opportunity to access additional funds for our community and the community foundation was pleased to provide grants to five (5) community Canada 150 projects.

We are very excited about the direction of the Columbia Valley Community Foundation and we thank the entire community for their support. We are honoured and humbled to fulfill our donors' charitable wishes and to help charitable organizations throughout the Columbia Valley.

CREATING A LEGACY FOR ARTS & CULTURE in our community



We know that a thriving cultural scene is vital to the long-term livability and success of our communities. That's why, in 2016, the Columbia Valley Arts & Culture fund was established. The Columbia Valley Arts & Culture fund is a designated, endowed fund that supports the Columbia Valley Arts Council – a local registered charity whose purpose is to foster the growth, awareness and appreciation of the arts in the Columbia Valley.

The fund was established in conjunction with the 40th anniversary of the Columbia Valley Arts Council. Formally registered in 1976, the Columbia Valley Arts Council grew out of the combined efforts of local artists with representatives of the museum, choir and supporters of the Kootenay Chamber Orchestra, to coordinate all such activities in the Columbia Valley. The Columbia Valley Arts Council resides in Pynelogs; a historic log building on the shores of Lake Windermere.

"Pynelogs is the cultural heart of the valley. We may have beautiful mountains but our community would be nothing without arts and culture," says Baiba and Pat Morrow in support of the fund.

Endowed funds are a great option for donors who wish to give legacy gifts or substantial donations. The Columbia Valley Community Foundation invests the capital, and in the case of a designated fund like the Columbia Valley Arts & Culture fund, the income generated goes directly to the beneficiary. This provides stable funding over the long-term without the administrative burden of re-applying annually for funds.

Donors who wish to support our local arts community are encouraged to contribute to the Columbia Valley Arts & Culture fund. The more the fund grows, the more we all benefit from an enhanced cultural scene.

Oonor Spotlight

W. Brett Wilson



Opportunities, collaborations, & stronger communities are just the start.

That's the philosophy of Columbia Valley Community Foundation donor W. Brett Wilson and his family. You might recognize Brett from the CBC television program Dragon's Den, but he's also a member of our Columbia Valley community – one who's invested in its long-term vitality.

"When I hit the 4-way stop in Radium", says Brett, "my blood pressure drops measurably. I enjoy the energy, the weather, and especially the people of the valley. Given that I intend to have a summer (or all-season) home in the Columbia Valley forever, the quality of life in the Valley is very important to me and the next generation of my family."

Brett chose the Columbia Valley Community Foundation as the conduit for a flow-through donation, which allows a single gift to benefit a variety of organizations around the valley.

"Generally, I connect my philanthropic work to the interest of family and friends," Brett explains. "I've also made the strategic decision to support the communities where I live, play and work. That's why I frequently reach back to my hometown of North Battleford, my real estate interests in Strathmore and the city I live, Calgary. Now I'm simply stepping things up in the Columbia Valley."

Brett's generosity supported 13 local non-profits and charities – and for flow-through donations like his, the Columbia Valley Community Foundation issues a single charitable receipt and looks after all the administrative work

of distributing the funds. This makes it easy for donors to keep track of their gifts and for donations to be put to good use immediately. Unlike endowed funds, the principal of flow-through funds is granted within 12-18 months of the receipt of the gift. That's a lot of impact for little effort.

The Columbia Valley Community Foundation – and the community itself – is grateful to donors who share their resources to make a difference.

UNIQUE WAY TO GROW COMMUNITY FOUNDATION ENDOWMENTS

Community foundations across the Columbia Basin, including the Columbia Valley Community Foundation, received a boost in 2016 thanks to an excellent new investment opportunity through the Columbia Basin Trust.

The Columbia Basin Trust was established in 1995, and earns money by investing in regional hydro-electric projects, Basin businesses, and market securities. In addition to its investments, the Trust offers a range of services, programs, and initiatives to support the social, economic, and environmental well-being of the Basin.

Now, the Columbia Valley Community Foundation can invest with the Trust with no administration fees and a guaranteed rate of return.

We are able to invest new donations each quarter, so that they start gaining interest right away and the funds can be withdrawn at any time.

It's simple, efficient, very low-risk, has the potential for an even better rate of return in the future and is available only to community foundations.

Access to great investment options, such as this one, is a compelling reason to donate to the Columbia Valley Community Foundation. Your donations will grow and support a range of vital programs and services across our beautiful valley.

In 2016, the Columbia Valley Community Foundation released our first Vital Signs report - the first for our region - published as part of a national program led by Community Foundations of Canada.

The report brings together local data and community knowledge on a wide range of interconnected topics from health and housing to education and the environment, providing a comprehensive, readerfriendly look at how the Columbia Valley is faring in key quality of life

The good news? The Columbia Valley is thriving in many ways. Our population is very well-educated, with an excellent high school completion rate and post-secondary education rate above the provincial and national averages. Our community is caring and highly engaged in volunteerism and philanthropy - and most feel a strong sense of belonging here.

BUT THERE IS STILL WORK TO BE DONE.

Work and earning top the list of concerns for Columbia Valley residents - and for good reason. The Vital Signs report shows a disparity between employment income and housing costs, and a wide gap in mean income for women and men. A large proportion of residents cite

a lack of employment options as their primary reason for moving away from the area - almost double the provincial average.

The demographics are also interesting. The community is getting older, and that will affect everything. We have lost families, and enrolment in local schools is down. Looking ahead, this baseline report will help us see where these trends are going, and ask how we can shift our focus to adapt to our community's changing needs.

The bottom line? People love living here and they love getting involved. It is really heartwarming to see that reflected in the numbers. Now we have to ask...

How can we make sure all the folks who want to settle down here are able to do it?

The Columbia Valley Community Foundation is one of 32 community foundations across who participated in Vital Signs 2016. More than 85 communities across Canada and around the world use Vital Signs to mobilize the power of community knowledge for greater local impact.

ENDOWMENT FUND INFORMATION

About our Funds

The Columbia Valley Community Foundation manages charitable gifts from donors whose generosity allows us to create permanent, income-earning funds that are distributed in the areas the donors wish to support.

Donations to the Foundation may be designated or undesignated by the donor:

- Undesignated donations under \$1,000 are allocated to operations
- Designated funds can be directed to endowed, flow-through or operating funds.

FUND TYPES WITHIN THE FOUNDATION'S ASSETS

ENDOWED FUNDS are endowed either permanently or for a specific period of time (generally 10-30 years). The contributed principal is invested and the returns from the investments are allocated to grants and operating fees. The donor can provide succession management instructions for the funds during, or after,

- Community funds give the Foundation the greatest flexibility to respond to current community needs. Donors can create named funds within the Community Fund.
- Designated funds are granted to specific, named charities.
- Donor Advised funds are normally established by individuals or families who wish to remain involved in granting decisions and disburse grants annually.
- Field of Interest funds are established by donors who wish to support their charitable interests: student awards, arts and culture, environment, recreation, literacy, health and safety, social services, community facilities, youth or education.

FLOW-THROUGH FUNDS are restricted funds. The principal of ("Restricted Flow-Through) Funds may be granted at any time as specified by Foundation policy or the donor, generally within 12-36 months.

OPERATING FUNDS come from non-designated or designated donations, and returns on investments from operating endowment funds, which are available to the Foundation for its operations.

Your will can provide a charitable gift of a specific amount, or a portion of the residue of your estate, to your named fund at the Foundation. The designated or donor advised fund agreement, signed during your lifetime, clearly sets out your intentions for the allocation of the annual grant from your fund to one or more federally registered charities, or general charitable interests. This gives you the flexibility to change the allocations during your lifetime without having to change the terms of your will.

At the end of your lifetime, when your estate gift is received into your fund, the Foundation's Board of Directors will ensure your wishes are honoured. You can choose to have family members be a part of your legacy fund at any time.


